## FIRST AMENDMENT TO THE GATES MATCHMAKER PLAN

Prototype Defined Contribution Basic Plan #3 and its corresponding Profit Sharing/401(k) Non-Standardized Adoption Agreement #001 ("PPA Plan Documents"); and
